 - a. The hospital was noncompliant with Mandatory Requirement 7.2.15 (Executing the Contract) for one instance. During fiscal 2012/13 the hospital undertook a RFQ for delivery services between the main site at Sault Area Hospital and the satellite facilities in Thessalon and Richard's Landing. As the expense was less than \$100,000 and as per hospital policy three quotes were obtained through a Request for Quote process. Subsequent to the process the hospital did not obtain a signed contract from the selected vendor for the period August 2012 to March 2013 at which time the service was cancelled.
